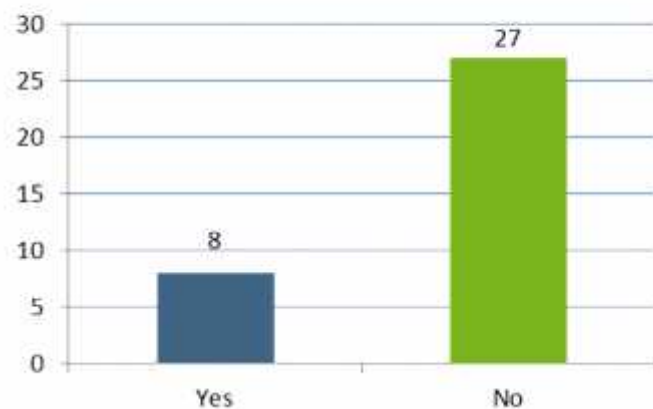

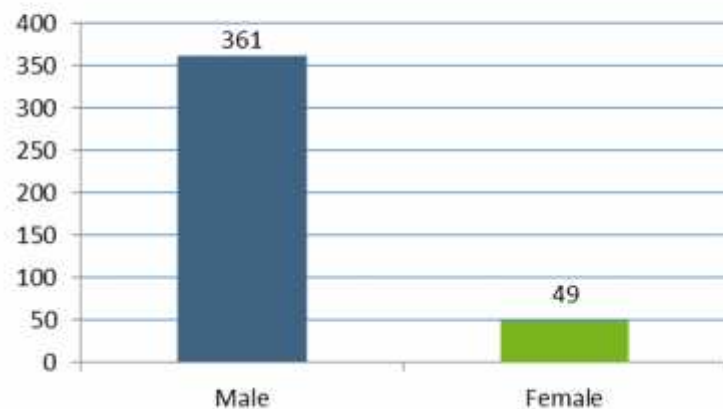
## Limitations

- Encourage access for new candidates

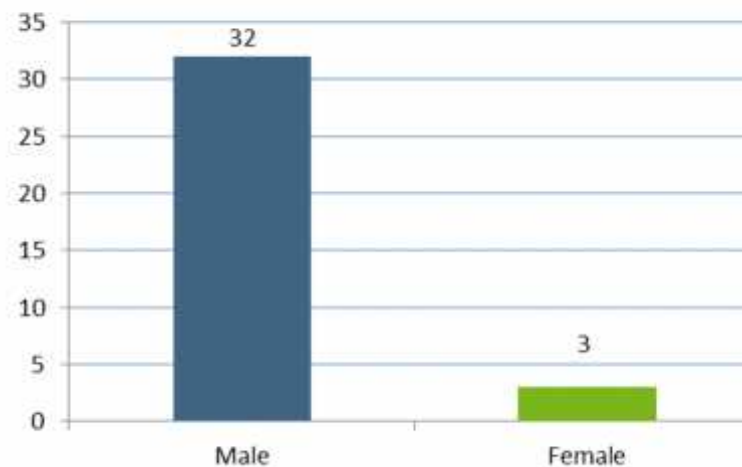
